FY 2026 Airport Rates & Fees

Effective October 1, 2026

AIRPORT DIRECTOR AUTHORITY

The Director is authorized to assess or waive fees not explicitly addressed in the Rates and Charges. Other fees may occasionally be incurred.

Lessee may not undertake or allow any party to undertake any alterations, erection, improvement, or other construction work on or to the premises unless it first requests and receives approval from the Director or their authorized representative.

ADJUSTMENT OF RATES & CHARGES

Leases are subject to periodic review and adjustment of rates and charges. This excludes ground leases or other agreements with defined adjustment terms.

MILITARY, FEDERAL, AND STATE OPERATIONS EXEMPTIONS

Military, Federal, and State aircraft are exempt from daily use facility fees.

The glass conference room is complimentary (if available) for up to one hour, provided a minimum fuel purchase and/or payment of applicable facility fees is made. It is highly recommended that this be scheduled ahead of arrival.

Optional Services:

- \$50 for use of the pre-function areas.
- \$100 for use of the galley.
- \$15 for each airport pot of coffee (including cream, sugar, artificial sweeteners, and cups).
- \$50 cleanup charge if food and drinks are served.
- \$10 for the use of the microphone in the boardroom.

Charges may be waived for Auburn University departments, clubs, or nonprofit organizations at the airport's discretion.

Please note that AUO currently does not offer leases on the terminal apron due to capacity constraints. Long-term aircraft not under a current lease are subject to daily or weekly fees.

Airport Gate & Build Access Cards

Tenants will receive two complimentary cards per signed lease. Lost, additional, or replacement cards are subject to a \$75 reissue fee.

GROUND LEASE RATE

The current ground lease rate is **\$.30/sq ft. annually**, for an initial term of thirty (30) years. All ground lease proposals shall conform to the Auburn University Regional “*Airport Guidelines for the Development, Design, and Construction of Aircraft Hangars by Private Entities*”, latest revision, and “*AUO Ground Lease Standards*” documents.

TERMINAL PARKING

The terminal parking lot is complimentary for non-concessionaire tenants and airport customers who park vehicles for less than seven (7) days. Customers may request parking a car for more than seven (7) days and must obtain a parking permit from the airport customer service desk. All long-term parking vehicles must be registered with the airport and will incur a monthly fee of \$50. Vehicles not registered are subject to tow and removal at the owner’s sole expense. *As of February 2026, the airport is unable to offer monthly parking rates. Commercial Operations Permit Fees

Auburn University Regional Airport offers a range of commercial ventures based on airport property. The fees below are independent of other aeronautical or non-aeronautical fees listed in this document. Operations are subject to all applicable federal, state, and local regulations.

Flight Training & Aircraft Rental – Commercial Entity (Part 61), Helicopter (Piston)	\$75/mo. per aircraft
Flight Training & Aircraft Rental – Commercial Entity (Part 61), Helicopter (Turbine)	\$100/mo. per aircraft
Aircraft Tie-Down (Terminal/FBO Apron)	\$100/mo.
Independent Aircraft Maintenance Operator	\$105/mo.
Aircraft Washing/Detailing Operator	\$45/mo.
Based Part 135 Operator	\$150/mo. per aircraft

Commercial Permit Fees are independent of hangar rentals, aircraft tie-downs, or other fees that may be the operator's/entity's responsibility.

Permit fees include five (5) hours of monthly conference or boardroom rental. Extra time will be billed at the market rates set in this document. Rooms are not guaranteed, and it is highly recommended that you schedule in advance.
