Analyses and reports on results obtained from databases. - Plans and implements natural resources management surveys to ensure sustainable management. This may include assisting program managers, graduate students, and other professional researchers with planning and implementing surveys and studies. - Oversees prescribed burning, timber marking, forest inventory, and associated natural resource management tasks. - Oversees undergraduate, graduate, and temporary employees tasked with natural resources management at military installations. - Oversees contractors completing natural resources, environmental, cultural, architectural, and engineering tasks at military installations. - Produces and presents research products, including project deliverable reports, white papers, MS Powerpoint presentations, and draft research articles. - surveys for and treat invasive species with herbicides. - May require travel to military installations throughout the continental United States
