JOB SUMMARY

Provides staff support, monitoring and oversight, training and program implementation for Alabama's foster youth regarding psychotropic medication.

RESPONSIBILITIES

- Designs and provides direct training including the use of Authorization and Monitoring Form for all stakeholders in the target area. Stakeholders include Prescribing Physicians, Department of Human Resources (DHR) staff, Therapeutic Foster Care Providers, Community Mental Health Agencies/Providers, and community stakeholders.
- Determines when psychotropic medication should be reduced or discontinued for each foster youth based on data provided by the BCBAs or a behavior analyst.
- Reviews and reports Residential Treatment Facility Statistics quarterly to include medication and PRN and communicate regularly with either APMRT Project Director or the Psychiatric Nurse.
- Recommend or develop a Comprehensive Trauma Assessment tool that will be used to assess each foster care youth in the assigned area.
- Provides quarterly usage reports regarding Psychotropic medication usage in the assigned area.
- Conduct quarterly strategic planning team meetings with DHR, Behavioral Analyst, AFAPA, Residential Treatment Facility Clinical Directors, Congregate Care Clinical Directors and Community Mental Health Directors.
