### JOB SUMMARY

Manages and maintains the Campus Recreation fields and landscaping. Responsible for monitoring field budgets and equipment inventory as well as ensuring efficient field operations.

### RESPONSIBILITIES

- Maintains all Campus Recreation fields and landscaping ensuring fields are safe and prepared for Campus Recreation games, practices, events, and informal recreation.
- Carries out administrative duties including monitoring budgets, purchasing, developing and enforcing policies and procedures, and developing and implementing goals and specifications related to the operations of fields and landscaping.
- Develops and manages a preventative maintenance plan for all fields and landscaping as well as a plan for ongoing maintenance.
- Manages inventory of equipment and supplies for work areas.
- Serves as point of contact for any outside contractors to ensure work is completed according to contract and/or purchase order standards.
- Assists with the coordination of emergency action plan for fields and work areas.
- Assists with making rain delay decisions and/or closing of fields due to weather.
- Hires, trains, and evaluates full-time, student, and seasonal employees. Responsible for appraising performance and ensuring that the training and development needs of staff are met.

The responsibilities listed above show the typical duties for jobs in this classification. Actual tasks may differ depending on the department's needs. Other similar duties may be assigned with discretion of the supervisor. Not every duty will apply to every position, and the amount of time spent on each task can change based on department needs.
