#### JOB SUMMARY

Performs and supervises others with daily operations of the grounds at Jack Key Golf Practice Facility.

### **RESPONSIBILITIES**

- Assists with planning, scheduling, instructing, training, and directing the crew in the performance of golf course maintenance procedures and job responsibilities.
- Performs and supervises the implementation of an overall turf health program including aeration, topdressing, and the application of pesticides, fertilizer, and chemicals to golf course turf.
- Oversees the operation and maintenance of the irrigation system.
- Assists in planning and supervising the maintenance of greens, tees, fairways, roughs, bunkers, etc.
- Mows golf course turf and performs daily course setup duties.
- Assists Superintendent in developing annual operating budget and plans for maintenance and capital improvement projects.
- Provides technical, operational, and safety training for employees to ensure that staff is working within golf course, city, state, and federal regulations.
- Performs other duties as assigned.

#### SUPERVISORY RESPONSIBILITIES

Supervisory Responsibility May supervise employees but supervision is not the main focus of the job.
