- Collects and deposits monies for the Athletics Department.
- Prepares and approves human resources, financial, and accounting forms for coding and accuracy.
- May train department employees on procurement policies and procedures and monitors and ensures compliance.
- Complies with all applicable National Collegiate Athletic Association (NCAA) and Southeastern Conference (SEC) regulations in the performance of job duties.
