JOB SUMMARY

Coordinates student athlete insurance coverage, medical care referrals and medical care instructions with the medical community and insurance carriers.

RESPONSIBILITIES

- Coordinates insurance claim processing for student athletes, answers questions regarding insurance coverage and resolves insurance claim problems.
- Coordinates medical care with physicians to ensure student athletes receive quick referrals when needed, and to ensure all pre-certification procedures are properly completed.
- Provides case management and follow-up of injured or sick athletes assessing recovery progress and coordinating care.
- Coordinates individual treatment plans between the medical community and the university athletic department.
- Ensures all student athletes have proper insurance coverage.
- Processes and ensures records are up to date for any change in life status that could effect insurance coverage.
- Coordinates care under the catastrophic management program.
- Develops, analyzes and presents reports on insurance utilization, claims, costs, etc.
- Complies with all applicable National Collegiate Athletic Association (NCAA) and Southeastern Conference (SEC) regulations in the performance of job duties.

The responsibilities listed above show the typical duties for jobs in this classification. Actual tasks may differ depending on the department's needs. Other similar duties may be assigned with discretion of the supervisor. Not every duty will apply to every position, and the amount of time spent on each task can change based on department needs.
