Job Summary

Maximizes the sales of priority tickets for athletic events through marketing, outbound and inbound sales efforts, and meetings with donors/customers.

Essential Functions

- Initiates outbound phone contact and face-to-face meetings with prospective ticket buyers and donors selling ticketing solutions to include season tickets, mini-plans, priority donations, group tickets, etc..
- 2. Acknowledges and expresses gratitude to donors for donating/joining clubs either by letter, phone call, in person.
- 3. Attracts new business through referrals and other prospecting activities.
- 4. Assists with the development of donor loyalty programs.
- 5. Coordinates with others in regards to the common database system used in determining customer eligibility, recording and distributing order information, and managing sales information.
- Produces or assists in producing marketing materials to support development efforts.
- 7. Provides and ensures excellent customer service and problem resolution in an effort to promote a positive image of Auburn University and the Auburn University Athletic Department.
