- Develops assessment protocols designed to measure program effectiveness in decreasing recidivism rates of program participants and the determinants of that decreased recidivism.
- Oversees program development and training, assessing the extent to which services to be provided are consistent with the current state of knowledge in the field.
- Oversees the clinical activity of Mental Health Specialists and Clinical Psychology graduate students.
- Provides clinical services as assigned and relevant to specific juvenile offenders and their families.
- Facilitates orientation and training for program participants.
- Gathers, analyzes, and compiles data for reports, correspondence, and general information.
