JOB SUMMARY

Coordinates the development and instruction of staff training curricula and materials specific to treatment, management, and education of adolescents participating a sexual offender-specific treatment program.

RESPONSIBILITIES

- Trains Division of Youth Services (DYS) personnel in policies, procedures, and unit-specific regulations.
- Assists with the development of curricula and materials specific to training, treatment, management, and education of adolescents with DHS.
- Coordinates training and meetings with direct care staff, contract staff, supervisors and agency personnel.
- Attends training meetings, workshops, conferences, administrative meetings, and other meetings as instructed.
- Maintains documentation of training conducted, attended, and forecasted, as well as other documentation as instructed by agencies and supervisors.
- Assesses training and learning outcomes through questionnaires and direct feedback.

The responsibilities listed above show the typical duties for jobs in this classification. Actual tasks may differ depending on the department's needs. Other similar duties may be assigned with discretion of the supervisor. Not every duty will apply to every position, and the amount of time spent on each task can change based on department needs.
