#### JOB SUMMARY

Coordinates and oversees all clinical aspects of a residential treatment program for juveniles who have been adjudicated for sex offenses.

- Manages, directs, and coordinates institutional clinical services and programs.
- Plans and coordinates institutional treatment services and program activities in conjunction with academic and clinical staff.
- Ensures that the program meets or exceeds training standard requirements of the American Correctional
- Plans and implements weekly therapeutic group meetings for staff and residents.
- Ensures all clinical activities meet expectations for implementation of the Good Lives treatment model.
- Coordinates clinical program activities with Educational and Residential Life programs and various
   Department of Youth Services programs and activities, as well as coordinates critical incident reporting.
- Reviews and signs release documents and other clinical reports and records.

#### SUPERVISORY RESPONSIBILITIES

Full supervisory responsibility for other employees is a major responsibility and includes training, evaluating, and making or recommending pay, promotion or other employment decisions.
