JOB SUMMARY

Coordinates the daily sales activities, food safety program, and inventory for the facility.

RESPONSIBILITIES

- Coordinates, organizes, and oversees the sales room products and equipment.
- Maintains and verifies USDA food safety records, supporting documentation, and necessary supporting research activities.
- Coordinates the department inventory including ordering all products and materials.
- Coordinates and interacts with vendors and contractors to schedule work and negotiate pricing.
- Develops and implements the marketing plan to add value to products offered for sale.
- Develops and submits label applications to the USDA Labeling and Consumer Protection Office for products developed in the meat lab.

The responsibilities listed above show the typical duties for jobs in this classification. Actual tasks may differ depending on the department's needs. Other similar duties may be assigned with discretion of the supervisor. Not every duty will apply to every position, and the amount of time spent on each task can change based on department needs.
