JOB SUMMARY

Pilot University aircraft to provide transportation for official University business.

RESPONSIBILITIES

- Serves as Pilot-in-Command of jet aircraft and responsible for passenger safety, comfort, and efficient operation of University aircraft ensuring compliance with all federal, state, local and university regulations, as well as policies and procedures specified in the ATD Flight Operations Manual.
- Preflights aircraft and plans flight in accordance with Federal directives.
- Reviews current policies governing the safe operation of University aircraft and suggests alternate policies to enhance safety.
- Performs weekly inspection to assess airworthiness of aircraft, cleans all portions of the aircraft interior and exterior as needed and restocks all consumable items in aircraft.
- Reviews industry and Federal guidelines for issues that impact University's aircraft operations and prepares records and maintains records required for compliance.
- Ensures all charts and approach procedure information is current and available for that flight.
- Senior Captain - Ability to take responsibility as Chief Pilot in absence. Mentors and guides Captain, Sr. First Officer, and First Officer positions.

The responsibilities listed above show the typical duties for jobs in this classification. Actual tasks may differ depending on the department's needs. Other similar duties may be assigned with discretion of the supervisor. Not every duty will apply to every position, and the amount of time spent on each task can change based on department needs.
