JOB SUMMARY

Manages the daily operations of the Air Transportation Department (ATD) hangar facility, including facility and aircraft maintenance.

RESPONSIBILITIES

- Oversees and maintains hangar facilities and equipment to ensure all are in safe operating condition.
- Troubleshoots and Inspects aircraft; performs preventative maintenance and detailed inspections ensuring that aircraft is in accordance with university, manufacturer and FAA requirements.
- Assists ATD flight crews during aircraft departures and arrivals ensuring aircraft, passenger, and crew safety.
- Inspects hangar grounds, facilities, equipment, and department vehicle daily and makes necessary repairs ensuring all are in safe operating condition.
- Maintains proper and updated records required by the University, Cescom, and/or federal or state guidelines.
- Assists with flight line activities including towing and fueling aircraft.
- May serve in an on-call status to maintain effective and continuous business operations.

May be responsible for training, assisting or assigning tasks to others. May provide input to performance reviews of other employees.
