Job Summary

Organizes and manages logistics of events, including researching appropriate events, organizes mod of participation, coordinates educational or promotional materials, and coordinates staff, faculty, and volunteer support services.

Essential Functions

- 1. Assists in planning and executing special engagements, develops and promotes marketing campaigns to increase engagement and awareness of the event.
- 2. Develops and coordinates events, builds relationships by developing and promoting interaction between the Board of Trustees, AU Foundation Board, College/School administration, business partners, alumni, faculty, staff, and students.
- 3. Develops and coordinates events specifically designed to foster interaction between the Board of Trustees, AU Foundation Board, College/School administrators, business partners, alumni, faculty, staff, and students.
- 4. Manages a balanced program of events aimed at enhancing the reputation, scope, and influence of a college or school, as well as the University overall.
- 5. Assists with arranging travel accommodations for individuals associated with special events.
- 6. Maintains a comprehensive events calendar and manages and adheres to the special events budget of a college of school
- 7. Supports and assists with existing programs, conferences, or events within the college or school.
- 8. Performs high level administrative and technical support duties.

Supervisory Responsibility

May be responsible for training, assisting or assigning tasks to others. May provide input to performance reviews of other employees.

The above essential functions are representative of major duties of positions in this job classification. Specific duties and responsibilities may vary based upon departmental needs.
