JOB SUMMARY

Under minimal supervision, performs a variety of routine accounts payable duties with an established spending limit. Responsible for the full accounts payable cycle including analyzing and approving invoices and payments for Procurement and Business Services. Responsible for taxable fringe benefit reporting and 1099 processing and reporting.

RESPONSIBILITIES

<ul style="list-style-type: none"> Leads the analysis and approval of a large volume of electronic invoices and payments while ensuring compliance with state spending policies and procedures. Such analysis includes, but is not limited to, the following: analyzes transactions for patterns in exceptions and utilizes independent judgment to approve or disapprove the request; identifies opportunities for increased efficiency, compliance, and cost-savings; investigates revenue opportunities such as early payment programs; and analyzes payment methods to ensure efficiency and cost-effectiveness. Works collaboratively with units to improve their compliance with current payment policies and procedures, providing additional training and support.
<ul style="list-style-type: none"> Ensures that proper coding, approvals, and required documentation are in place for the processing of a variety of payables, including vendor payments, travel reimbursements, human participant payments, and procurement card payments. Ensures compliance with University policies and procedures as well as applicable state and federal regulations. Keeps supervisor informed of any and all issues or anomalies that may arise.
<ul style="list-style-type: none"> Generates and analyzes system reports to identify spending patterns and to ensure expenditures are within policy guidelines.
<ul style="list-style-type: none"> Oversees the flagging, reporting, and issuance of 1099 payments in compliance with IRS regulations.
<ul style="list-style-type: none"> Communicates with internal and external stakeholders on accounts payable matters to ensure compliance with all Auburn University policies, procedures, and state and federal laws.
<ul style="list-style-type: none"> Leads the compilation and reporting of the taxable fringe benefits paid by Auburn University and its institutionally-related foundations: Auburn University Foundation and Tigers Unlimited Foundation.
<ul style="list-style-type: none"> May oversee the processing performed by entry level Accounts Payable Analysts.
<ul style="list-style-type: none"> Performs other related duties as assigned.
