JOB SUMMARY

Directs, administers, and oversees fiscal and business operations of the College of Veterinary Medicine (CVM)

RESPONSIBILITIES

- Exercises primary responsibility over the accounting, reporting, budgeting, and monitoring of all financial matters within the CVM
- Prepares and monitors the operating budget for the CVM and provides financial reporting and analysis for funding activities, business operations, project accounting, and budgetary counsel in support of the college's strategic plan.
- Advises and assists management officials on complex fiscal matters, budget considerations, transfer of funds, and other fiscal matters related to the CVM.
- Develops and implements fiscal policies and procedures which ensure that generally accepted accounting principles, regulations governing contractual agreements, Federal and State regulations, and Auburn University guidelines are employed.
- Responsible for the human resources activities to include position development, performance evaluation, reclassification, promotion, student employment, etc., and productively engages university human resources.
- Assists with strategic planning, collection/analysis/reporting of data, business development, and administrative reporting (accreditation and program assessment).
- Serves as facilities manager for the building and infrastructure, to include security and access and facility maintenance.
- Oversees the instructional and information technology operations of the school and ensures efficient use of such technology for faculty, staff, and students.
- Provides oversight for special events for the CVM.
- Prepares reports for various agencies as needed.
- Serves as a member of the college's Executive Committee and other committees/cabinets.
