JOB SUMMARY

Provides continuing medical services for the State Wellness Center.

RESPONSIBILITIES

- Provides full scope of primary care services which fall under field of training including but not limited to diagnosis, treatment, coordination of care, preventative care, and health maintenance to patients twelve years and above.
- Works collaboratively with members of the healthcare team including pharmacists, nurse practitioners, and nursing staff.
- Evaluates health history and performs physical examinations.
- Diagnoses and directs counseling for each patient on a plan for treatment.
- Prescribes medication in accordance with Alabama statute and professional practice guidelines. Orders referrals for patients requiring services not offered at the State Wellness Center.
- Reviews incoming reports (e.g. lab, x-ray, EKG) and follows up in a timely manner.
- Participates in peer review, quality assurance, provider meetings, and other clinical and operational meetings as requested.
- Assist in updating protocols and principles of practice as requested.

SUPERVISORY RESPONSIBILITIES

Supervisory Responsibility May supervise employees but supervision is not the main focus of the job.
