### JOB SUMMARY

Oversees and manages trucking operations at the National Center for Asphalt Technology (NCAT) Test Track.

#### **RESPONSIBILITIES**

- Maintains a fleet of 7 Class 8 vehicles; performs maintenance on high-mileage tractors to keep them
  performing at their best and to keep drivers safe. Services and performs routine maintenance on all vehicles
  for the test track.
- Coordinates trucking activities to include scheduling of activities for drivers and monitors weather conditions in regards to driver safety and oversees fleet operations.
- Assists with the collection of data measurements including cutting cores from the test track in aid of research. Helps set up trucks for fuel tests.
- Drives trucks during shift when short-handed.
- Assists with construction every 3rd year during rebuild of test track.

### SUPERVISORY RESPONSIBILITIES

Full supervisory responsibility for other employees is a major responsibility and includes training, evaluating, and making or recommending pay, promotion or other employment decisions.
