JOB SUMMARY

Manages the care of assigned animals and provides routine maintenance to equipment, facilities, and land through self and others.

RESPONSIBILITIES

- Manages and participates in the daily operations and maintenance of an animal care and holding complex for a variety of large animal species that supports veterinary medicine teaching, research and treatment programs.
- Informs supervisor or department head of work progress, present and potential problems, and makes suggestions for new or improved ways of addressing problems.
- Assists in the preparation planning and execution of special events and activities.
- Provides technical and mechanical assistance in the maintenance of fleet equipment and schedules annual equipment maintenance.
- Inspects, records maintenance of, and advises on the management and care of lands, facilities pastures and animals.
- Assists the director in planning and deciding protocols pertaining to facilities, equipment and supplies, animal health and care operations, and employees.
- Performs other related duties as assigned.

SUPERVISORY RESPONSIBILITIES

Supervisory Responsibility

Full supervisory responsibility for other employees is a major responsibility and includes training, evaluating, and making or recommending pay, promotion or other employment decisions.
