JOB SUMMARY

Performs professional analyses, tests, and diagnostic procedures in a medical laboratory.

RESPONSIBILITIES

- Conducts chemical analysis of specimens; including blood, urine, and spinal fluid, to determine presence of normal and abnormal components.
- Operates, maintains, and cleans equipment used in quantitative analysis.
- Performs quality controls in testing and decides if results are within acceptable ranges and researches and corrects problems.
- Prepares a variety of culture media for the development and identification of organisms.
- Enters data from analysis of medical tests and clinical results into the data management system.
- Trains and directs lab assistants, staff, and students on proper methods of collection of specimens and laboratory testing.
- Inventories supplies, materials, and equipment for economic efficiency of lab.
- Prepares technical reports on procedures and results of laboratory tests and examinations.
- Performs clerical duties to include answering phones, filing, labeling and recordkeeping.
