### JOB SUMMARY

Under direct supervision, performs basic-level landscape functions to maintain and improve University grounds.

### RESPONSIBILITIES

- Maintains University grounds using hand tools such as a shovel, pick, and rake, as well as power tools including a weed eater, edger, hedge trimmer, tiller, and blower.
- Operates a push and riding mower to mow grass and operates utility task vehicles to perform work.
- Performs basic landscape-related duties on University grounds to include weed pulling, plant watering, pine straw/mulch installation, and sod installation.
- Provides debris removal with cleaning and litter control equipment to keep University grounds, streets, and parking lots free of dirt, leaves, trash, and other debris. Maintains University hardscapes through the use of a pressure washer.
- Maintains and cleans hand and power tools and equipment including, but not limited to, checking fluid levels and blade sharpness.
- May be responsible for meeting and maintaining training and certifications requirements as outlined by the applicable department's training and credentialing requirements.
- May perform other related duties as assigned.

#### SUPERVISORY RESPONSIBILITIES

May be responsible for training, assisting or assigning tasks to others. May provide input to performance reviews of other employees.
