JOB SUMMARY

Oversees employees, subcontractors, budget compliance, and records maintenance for construction projects.

RESPONSIBILITIES

- Supervises the activities and operations for construction and renovation projects including (but not limited to) form carpentry, foundations, framing, installing ceilings, roofs, flooring, structural steel, and masonry.
- Plans and organizes construction and renovation project requirements.
- Maintains records and documentation of work activities, supplies, and equipment.
- Supervises the installation of plumbing and drainage systems.
- Operates heavy equipment on job site, when necessary.
- Supervises the installation of pipe, fittings, and fixtures of heating, water, plumbing, and drainage systems.
- Performs and supervises a variety of carpentry tasks and installations.
- Maintains records and documentation of work activities, supplies, and equipment.
- Layout foundations, footings, and maintain proper elevations for construction.
- Serves as a construction technician as needed.

SUPERVISORY RESPONSIBILITIES

Full supervisory responsibility for other employees is a major responsibility and Supervisory Responsibility includes training, evaluating, and making or recommending pay, promotion or

other employment decisions.
