### JOB SUMMARY

Reporting to the Director, Landscape Services, this position oversees urban forest management on Auburn's core-campus properties. Collaborates with university project leadership in accordance with the Design and Construction Standards by providing accurate GIS data features and expert-level consultation. Strategizes future tree canopy expansion in accordance with the Landscape Master Plan (LMP).

### RESPONSIBILITIES

- Oversees, develops, and implements all aspects of urban forest management and Arboriculture practices on all University campus properties.
- Updates and maintains a comprehensive GIS dataset to facilitate responsible management of all urban forest assets on University properties and lands. Assesses all core campus trees for risk, submit tree removal requests. Provides primary oversight of a Board of Trustee's policy in the Tree Preservation Policy. Works with the Assistant Director of Campus Planning to uphold the policy on a per project basis.
- Reviews plans and advises all project design team members on tree and landscape protection. Works with
  multiple internal and external project leads to provide expert- level tree consultation at all project stages preand post-construction.
- Collaborates with Planning, Design and Construction regularly to strategize further tree canopy expansion efforts in accordance with the LMP. Initiates and manages canopy enhancement projects; coordinates with internal departments and/or contracted services to ensure that the proper support is available for the successful and timely completion of work.
- Develops and maintains a quality control program to improve arboricultural operations and ensure high standards of work. Tracks status of work accomplishments, analyzes data, and prepares reports, recommendations, and plans in support of increasing arboricultural performance, productivity and improve land management practices.
- Coordinates communications and activities among Landscape zones, services, and projects; other Facilities Management Departments; outside contractors; and Auburn University customers and affiliates. Communicates with stakeholders to maintains awareness of activities, maximize efficiencies, and resolve questions.
- Oversees the management of a historic site in the Auburn Oaks at Toomer's Corner which includes rolling cleanup efforts of in-house and contracted crews, cooperating with internal communications offices concerning media inquiries, and developing a longterm site plan to preserve the rolling tradition and the security of the site.
- Communicates with campus constituents and various other stakeholders to keep them informed of work progress and answer questions regarding projects or other matters concerning University trees.
- Manages the Campus Timber Reclamation Program by working with key members of AUFM and related
- academic departments to evaluate only campus trees approved for removal as future wood products for

- educational or end-use purposes. Coordinates the logistics required to convert standing timber to an enduser
- product. May be required to present budget reports on the program's financial efficiency on an
- annual basis.
- Ensures all standards are met to maintain the Tree Campus Higher Education designation.
