#### JOB SUMMARY

Under general supervision, assists in the removal/installation process of campus-wide signage such as building monuments and lettering, door directories, and vinyl sign creations. Assists in the removal/installation of sign poles of various styles and sizes. Assists in the maintenance, removal, and installation of parking lot, crosswalks, and street paint markings.

#### RESPONSIBILITIES

- Creates signage using equipment such as vinyl plotter, engraver, and flat-bed printers.
- Installs signage on monument signs, door directories, building exteriors, and coroplast sheeting.
- Assists in preparing/installation of street marking paint on roadways and parking lots.
- Demonstrates advanced abilities to use hand and power tools such as post hole digger, augur, shovel, drill, leaf blower, etc.
- Demonstrates a working knowledge of ADA standards and regulations pertaining to interior signage and parking lot signage as well as parking lot spacing.
- Will be responsible for meeting and maintaining training and certification requirements as outlined by the department's training and credentialing requirements.
- Responsible for pressure washing sidewalks and parking lots without supervision.
- May perform other related duties as assigned.
